Subject :- Standard Operating Procedures (SOP) for DDU-GKY- Look & Feel of Training Centers & Uniform for beneficiaries- Reg.

This notification is in continuation to the notification number 25/2014 issued on 21st October 2014. It is hereby informed that the new designs for Siganges and Uniform for Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) and Roshini Program are finalized by the Ministry. These designs supersede the designs notified (under section 5.1.1 and 5.3 of Chapter 5) in Standard Operating Procedures (SOP) which was issued in July 2014.

2. Signages:

2.1 The new design (open) files for signages (Internal and External) and logo for DDU-GKY and Roshini are available on our website www.aajeevikaskills.gov.in under the tab "Resources". PIA's may obtain State/SRLM logo from State Government/SRLM concerned in order to prepare the signages. These signages need to be put in place within 15 days of issue of this notification even if it means replacing earlier signages.

3. Uniform:

3.1 The new designs for uniform (for DDU-GKY and Roshini program) is uploaded on our website www.aajeevikaskills.gov.in under the tab "Resources". As noted in point number 5 of Notification no 25/2014 , those PIAs who have not yet taken action to procure uniforms , are required to ensure that uniforms are provided within 45 days of this notification.

3.2 However it is noted that those PIAs who have already incurred expenses in procurement of uniform (either in the form of fabric or garments) as per designs notified in SOP issued in July 2014, may continue to use uniform for a maximum period of 45 days from date of this notification or till their stock lasts, which ever is earlier. For this PIAs need to take prior approval of MoRD in prescribed format by providing information about already incurred costs & booked orders. The format in which information need to be provided is uploaded on our website under Resources Tab.

3. All Project Implementing Agencies (PIAs) are directed to exclusively use the above mentioned design files. Any deviation from the said design shall be considered as a violation.

4. The Q Team of PIA, SRLM and CTSA shall exclusively refer to the above mentioned design files to ensure compliance

5. This order comes into force with immediate effect.
