Sub: Cancellation of Roshni Project sanctioned to M/s Aroh Foundation for the State of Jharkhand under DDU-GKY -reg.

It is stated that the Ministry of Rural Development had sanctioned a Placement Linked Skill Development project for skilling of 3000 candidates under Roshni initiative under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (erstwhile Aajeevika Skills) in favour of M/s Aroh Foundation in Jharkhand State vide sanction order No. J-17021/26/2013-Aajeevika Skills (A, B, C) dated 20.1.2014. Subsequently, M/s Aroh Foundation, vide its letter dated 14.10.2014 has requested for withdrawal from implementation of the said Roshni project. The request of M/s Aroh Foundation has been accepted in terms of recommendation of State Government of Jharkhand vide letter No.1852 dated 26.2.2015, and with due concurrence of Central Technical Support Agency, i.e NIRD &PR, Hyderabad, vide its letter no. NIRD&PD/DDU-GKY/Aroh Foundation/Jharkhand/2015-16 dated 17.3.2015.

2. Accordingly, it is hereby stated that the above mentioned sanction orders dated 20.1.2014 in favour of M/s Aroh Foundation for skilling of 3000 candidates under Roshni project in Jharkhand State stands cancelled with immediate effect.. This has the approval of the Secretary (Rural Development).
