Subject: - Standard Operating Procedures (SOP) for Aajeevika Skills- Uniform for Beneficiaries and Look & Feel and name board of Training centre - Reg.

Clause 5.3 of the Standard Operating Procedures (SOP) of July 2014 for Aajeevika Skills lays down the protocol for distribution of uniform to the candidates in the batches frozen for commencing the Placement Linked Skill Development courses. As per the SOP the uniforms are required to be distributed along with the Welcome Kit and all the candidates are required to compulsorily attend the classes only in uniforms. The colour and quality of cloth of the uniform have been specified in the SOP.

2. However, recently, the Ministry has proposed to strengthen and rename the Placement Linked Skill Development program as Pandit Deen Dayal Uphadaya Grameen Koushalya Yojana (DDU-GKY). The branding and design for the revamped program is underway, and is likely to lead to revision in the colour and logo design to be used for the uniform.

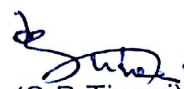
3. In this context, it is hereby stated that in order to avoid delays in commencement of Skill Development courses, and also to avoid stock-piling of uniforms with PIAs which may be unusable with revision in design, all candidates enrolled under Aajeevika Skills are temporarily allowed to attend the courses in formals without above specified uniforms.

4. Further the requirement of Look & Feel of Training Centres including Training Centre Name Board (as per Clause 5.1.1 and SF 5.1 A1& SF 5.1 A2 of SOP) is also temporarily withdrawn on account of the same.

5. The above mentioned exemptions in respect of Clause 5.3 and 5.1.1 of the SOP, July 2014 will be available for a period of 45 days from the date of new notification.

6. All PIAs are advised to take suitable steps to ensure compliance in this regard.

7. This order comes into force with immediate effect in partial modification of Notification No.17 & suppression of Notification No.20 of 2014.
