Subject: Cancellation of Project sanctioned to M/s International Computer Institute for the State of Uttar Pradesh under DDU-GKY -reg.

It is stated that the Ministry of Rural Development had sanctioned a Placement Linked Skill Development project for skilling of 500 candidates under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) in favour of M/s International Computer Institute (erstwhile known as M/s International Craftman Institute) in Uttar Pradesh State vide sanction order no. J-17036/38/2013 Aajeevika Skills (Part) (A, B, C) dated 20.05.2014. In terms of the Standard Operating Procedure M/s International Computer Institute was required to enter into an MoU with State Government and the Central Technical Support Agency (CTSA), in this case NABCONS. Subsequently, it has been brought to the notice of Ministry by CTSA that M/s International Computer Institute did not execute MoU despite follow up by CTSA. However, M/s International Computer Institute, vide its email dated 19.08.2015 & letter dated 19.09.2015 has states its inability to undertake the sanctioned project and has requested for withdrawal from implementation of the sanctioned DDU-GKY project. NABCONS vide its letter no. NABCONS.CO (ND)/677/2015-16 dated 03.09.2015 has also recommended cancellation of the sanctioned project in favour of M/s International Computer Institute. The request of M/s International Computer Institute has been considered and accepted by the competent authority in the Ministry.

2. Accordingly, it is hereby stated that the above mentioned sanction order no. J-17036/38/2013 Aajeevika Skills (Part) (A, B, C) dated 20.05.2014 in favour of M/s International Computer Institute (erstwhile known as M/s International Craftman Institute) for skilling of 500 candidates under DDU-GKY project in Uttar Pradesh State stands cancelled with immediate effect.
