**Sub: Cancellation of Permanent Registration Number (PRN) DL2016RT7773
allotted to M/s Bharat Sashaktikaran Trust -reg.**

Whereas M/s Bharat Sashaktikaran Trust had applied online for allotment of Permanent Registration Number with the Ministry of Rural Development for undertaking placement linked skill development projects under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY).

2. Whereas M/s Bharat Sashaktikaran Trust was allotted Permanent Registration Number (PRN) **DL2016RT7773** on the basis of its application. The details of PRN issued are available on Ministry's website <http://ddugky.gov.in> for public information.
3. Whereas it has come to the notice of Ministry that M/s Bharat Sashaktikaran Trust had been collecting franchisee fee from various organizations by misstating and misrepresenting DDU-GKY Guidelines. The Ministry has taken a serious view of this act of M/s Bharat Sashaktikaran Trust as its intention to fraudulently derive monetary gains.
4. Whereas M/s Bharat Sashaktikaran Trust was given a show-cause notice dated 11 February 2016 to give its explanation for why action should not be taken to revoke its Permanent Registration Number under DDU-GKY and any other action against it for the abovementioned fraudulent action.
5. Whereas M/s Bharat Sashaktikaran Trust submitted its reply to show cause notice vide its letter dated 26 February 2016. Taking into account the reply furnished by M/s Bharat Sashaktikaran Trust, the Ministry has held the reply as inadequate to disprove the charges against M/s Bharat Sashaktikaran Trust. It is held that M/s Bharat Sashaktikaran Trust had willfully attempted to derive monetary gains by misrepresenting and misstating DDU-GKY Guidelines to other organizations.
6. Taking into account the seriousness of charge on M/s Bharat Sashaktikaran Trust, it is hereby stated that PRN DL2016RT7773 allotted to M/s Bharat Sashaktikaran Trust

stands cancelled with immediate effect, and the same cannot be used for applying for any placement linked skill development project under DDU-GKY or for any other purposes in dealing with the Government. Further, M/s Bharat Sashaktikaran Trust is debarred from applying for another Permanent Registration Number under DDU-GKY for a period of three years from the issue of this order. M/s Bharat Sashaktikaran Trust is also directed to file FIR with police against person(s) it has claimed to have guided it into believing it has been sanctioned DDU-GKY project. Further, M/s Bharat Sashaktikaran Trust shall have to submit an Action Taken Report on the filing of FIR whenever it applies for Permanent Registration Number again after the debarred period of three years.
