Sub: Cancellation of Permanent Registration Number (PRN) AP2015RF2437 allotted to M/s SOCIETY FOR HUMAN AWARENESS AND RURAL DEVELOPMENT-reg.

Whereas M/s "SOCIETY FOR HUMAN AWARENESS AND RURAL DEVELOPMENT" had applied online for allotment of Permanent Registration Number with the Ministry of Rural Development for undertaking placement linked skill development projects under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY).

2. Whereas M/s Society for Human Awareness and Rural Development was allotted Permanent Registration Number (PRN) AP2015RF2437 on the basis of its application and copies of supporting documents, which included copy of PAN No.AACTS1981H indicating date of incorporation/formation 30-11-1990. The details of PRN issued are available on Ministry's website <http://ddugky.gov.in> for public information.

3. Whereas on the basis of a specific complaint received regarding manipulation in the date on the copy of PAN card submitted by M/s Society for Human Awareness and Rural Development, the Ministry requested Directorate of Income Tax to verify the PAN card details vide Ministry letter No. J-17060/67/2014-DDU-GKY dated 20th May, 2015. The Directorate of Income Tax vide its letter No. DGIT(S)/DIT(S)/1/PAN/Grievances/0004/12162/2015/4612 dated 15th June, 2015 has informed that after examination of copy of the PAN card, furnished by M/s Society for Awareness and Rural Development, it has been found that the said PAN card bearing date of incorporation "30-11-1990" was neither printed by the income tax department and nor was the same printed through PAN services providers, hence, the said PAN card is not genuine.

4. It is stated that the Ministry has viewed this act of furnishing false document by M/s Society for Awareness and Rural Development seriously. It is further stated that this action violates the declaration given by authorized person of M/s Society for Human Awareness and Rural Development (i.e. Shri Gouni Narsimha Goud) at the time of application for PRN, wherein it is stated that the information furnished is complete and correct in all respects, and in case any of the information in the registration application is found to be false or incorrect, then the



registration may be cancelled and the authorized person would be liable for any other action by the Government.

5. Taking into account the fact that the copy of PAN card furnished to the Ministry for registration is not genuine (as informed by the Directorate of Income Tax), implying that the copy of PAN card is false and incorrect, and the fact that this violates the declaration furnished by authorized person in the PRN application form, it is hereby stated that PRN AP2015RF2437 allotted to M/s SOCIETY FOR HUMAN AWARENESS AND RURAL DEVELOPMENT stands cancelled with immediate effect, and the same cannot be used for applying for any placement linked skill development project under DDU-GKY or for any other purposes in dealing with the Government.

6. This order comes into effect from the date of issue.
