Subject: Extension of MoU of Government Organizations empaneled for undertaking DDU-GKY Projects-reg.

It is stated that vide Notification no.65/2017, following Government Organizations were empaneled for undertaking projects under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY):

3	Institute for Design of Electrical Measuring Instruments (IDEMI), Mumbai, Maharashtra
4	Indo German Tool Room (IGTR), Aurangabad Maharashtra

2. The above empaneled agencies had signed a Memorandum of Understanding (MoU) with Rural Skills Division of MoRD for implementing DDU-GKY projects as "Government Agencies" as per terms and conditions laid down in the agreement signed between the agencies and this Division.

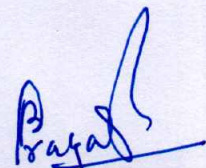
3. This is to inform that the tenure of MoU between all above 4 agencies and this Division is being renewed up to 31st March 2023 subjected to following additional conditions (along with terms & conditions in the existing MoU):

a) Agencies may apply for a fresh project in the same State/UT, where they are already implementing a DDU-GKY project, only if, placement percentage achieved in earlier project is equal to or more than 70%.

b) Agencies may apply for new projects in other States/UTs if the overall placement percentage achieved in all projects being implemented across India is equal to or more than 70%

4. All the States/UTs are thus requested to keep above conditions in view while sanctioning or approving new projects being applied by the above agencies.

5. This issues with the approval of the competent authority.

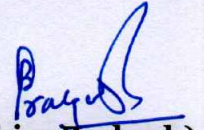
