NOTIFICATION NO. 52/2017

It is hereby stated that M/s India Can Education Pvt. Ltd. had been sanctioned a placement linked skill development project under DDU-GKY (erstwhile Aajeevika Skills) in the State of Assam vide sanction order No. J-17013/07/2014-Aajeevika Skills dated 30.09.2014. Taking into account the violations of Guidelines, competent authority in the Ministry had imposed a penalty of closure of project with recovery of funds released (with 10% interest) to M/s India Can Education Pvt Ltd vide order No. J-17013/07/2014-Aajeevika skills dated 4th July, 2016. The decision had been upheld by the Appellate Authority in the Ministry. Subsequently, the State had re-considered the case and allowed M/s India Can Education Pvt Ltd. to continue with the project. State had also requested the Ministry to reconsider its decision and allow the project to continue.

2. Now, in order to examine the State Government's request, Ministry has set up a Fact Verification Team under the Chairmanship of Director (Skills), Ministry of Rural Development to :

(i) ascertain whether any facts relevant to the case have been missed out in Ministry at the time of passing the order No. J-17013/07/2014-Aajeevika Skills dated 4th July, 2016 for closure of the project and recovery of 1st installment along with 10% interest.

(ii). verify placement details of at least 10% candidates placed in jobs by M/s India Can Education Pvt Ltd. in the project. Entire list of placed candidates to be provided by M/s India Can Education Pvt. Ltd.

3. The Fact Verification Team shall consist of:

(i) Director (Skills), MoRD- Chairperson

(ii) Project Director, NIRD & PR

(iii) Project Manager, NIRD & PR

(iv) Ms. Tenzing Choesang, MoRD

(v) Ms. Dhriti Bania, MoRD

(vi) Representative of State Government

Project Manager, NIRD & PR in Assam shall provide administrative assistance to the Team.

4. The Fact Verification Team shall provide a detailed report to the Ministry within one month of issue of this notification.
