Sub: Process for registration as partner for implementing DDU-GKY -reg.

It is hereby stated that the Ministry has reviewed the existing process for registration and issue of Permanent Registration Number (PRN) to a prospective Project Implementing Agencies as partner in Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY), the placement linked skill development program for rural poor youth. It is stated that as part of streamlining the process of registration of prospective Project Implementing Agencies, the following process shall be followed henceforth in disposal of applications for PRN:

- (i) All eligible organization seeking to partner with DDU-GKY for implementing placement linked skills development projects shall be required to register and obtain Permanent Registration Number (PRN) through online application at DDU-GKY website (<http://ddugky.gov.in>)
- (ii) Only such applications which are filed on <http://ddugky.gov.in> shall be entertained/considered for grant of PRN.
- (iii) PRN applications shall be rejected in case documentary evidence attached with application is found insufficient, illegible and having wrong information. However, such rejection of application would not foreclose any civil/criminal action by the Ministry against an applicant organization for misrepresentation of facts or furnishing wrong information or furnishing fake documents.
- (iv) In case of rejection of an application for PRN on grounds of typo-error, insufficient or illegible documentation, an organization may apply afresh after ensuring necessary corrections in the applications.
- (v) When an applicant for PRN has received a Temporary Reference Number (TRN), and such applicant is unable to complete the application process (i.e. 'Submit' the application online) within 30 days of receipt of TRN, the application and TRN shall be time-barred and

lapse automatically. However, an applicant organization may apply afresh.

(vi) The Ministry reserves the right to notify an application fee for issue of PRN.

(vii) The Ministry reserves the right to review PRN allocated annually and take action for cancellation of PRN in all such cases where the PRN has not been used for making any project application. Such review would also include PRNS issued prior to the issue of this notification. However, before cancelling such PRN, the Ministry shall issue show-cause notice and provide an opportunity to the PRN holder to furnish a written response to the show cause notice. COO (Skills), Rural Skills Division in the MoRD shall be the competent authority to decide cancellation and Joint Secretary (Skills), MoRD shall be the appellate authority in the matter.

(viii) PRN is mandatory for filing project application for DDU-GKY projects.

2. This notification comes into force with immediate effect.
