Notification No.6/2014

Subject: Payment of second installment to Project Implementing Agencies, clarification -reg

As per Table 6 under Section 5.9 of the Aajeevika Skills Guidelines, 2013, the second installment, i.e 50% of the project cost, can be released to a Project Implementing Agency (PIA) subject to fulfillment of the following conditions by the PIA :-

- *a. Spending 60% of funds disbursed as 1st installment as visible in web site.
- b. Achieving 40% of physical target inclusive of sub-targets such as for SC/ST, minorities etc.
- c. Submitting audited expenditure statement like P&L statement, Balance sheet etc with respect of previous year for cases after 30th September".

2. A clarification has been sought on the above referred condition no. (b) as to whether the "physical target" relates to the entire project target or to the "corresponding physical target" for the funds released as 1st installment.

3. It is clarified that the "physical target" specified in condition no. (b) for second installment in Table 6 under section 5.9 of Aajeevika Skills Guidelines, 2013, relates to the "corresponding physical target" for the funds released as 1st installment. In other words, item (b) in Table 6 under section 5.9 of the Aajeevika Skills Guidelines, 2013, is henceforth modified as follows:

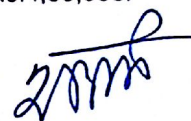
"b. Achieving 40% of corresponding physical target inclusive of sub-targets such as for SC/ST, minorities etc".

4. An illustrative example is noted below:

In case a project has been sanctioned for skilling of 100 candidates at a total cost of Rs.30,00,000 (i.e. @ Rs.30,000 per candidate) and a first installment of Rs.7,50,000 (i.e 25% of the project cost) has been released, the PIA shall have to fulfill the following conditions for availing 2nd installment:

- (a) show a spending of Rs.4,50,000 (i.e 60% of funds disbursed as 1st installment),
- (b) complete training of at least 10 candidates (i.e 40% of 25 candidates targeted for training with 1st installment), including achievement of training of candidates from sub-targets for Scheduled Caste, Scheduled Tribe and Minorities (as per the corresponding break-up given in the sanction order, which may vary for each State), and a minimum placement of 8 candidates (i.e. 75% of trained candidates, rounded-off).
- (c) submit audited expenditure statements as documentary evidence for spending Rs.4,50,000.
